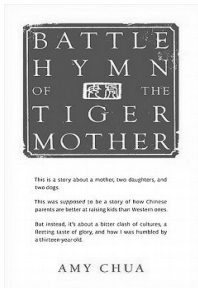
AAUW Book Group

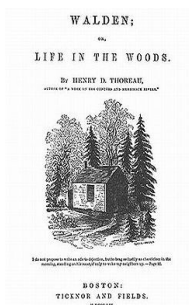

November Program Review

Women in Science, Technology, Engineering, and Mathematics (STEM) Fields

Glimpses into the lives of women in the STEM fields were the highlight of a panel coordinated by Tiffany Bredeck at UWMC on November 15. Bredeck is a spring 2012 graduate of Upper Iowa University with a B.S. in Psychology and currently a student at UWMC fulfilling prerequisites for admission to medical school. She is a former student affiliate and a new AAUW Wausau Branch member.

The program began with an intelligent Powerpoint presentation by Bredeck giving the current status of women in STEM fields. The panelists that followed were well chosen and their honesty and openness were refreshing. While the audience was small, (18 including panelists) I felt this led to greater openness in audience questions and panelist's responses. The advice to women students aspiring to major and work in the fields was especially valuable.

December Brunch Program Review

Holiday Brunch: *How the DNR's new rules allowing hunting in state parks affects every one of us*

Our annual holiday brunch held each year at the lovely Wausau Country Club took place on December 1. It featured brunch followed by guest speaker **Jane Wiley, Chair of the Natural Resources Board of the Wisconsin Department of Natural Resources (DNR)**. Wiley spoke highly of the seasoned staff of the DNR. She gave us a behind the scenes look at politics within today's divisive state government. According to Wiley, what needs to be overturned is not the recently passed bill, she calls it a "feel-good bill". Because of its unintended consequences of potentially interfering with the safety of state park hikers, bikers, and neighboring communities, the amendment that allows hunting in state parks needs to be overturned.

Fourth anniversary of passage of Lily Ledbetter Fair Pay Act

The Lilly Ledbetter Fair Pay Act of 2009 was the first bill signed into law by President Barack Obama on January 29, 2009. The Act amends the 1964 Civil Rights Act. It states that the 180-day statute of limitations for filing an equal-pay lawsuit regarding pay discrimination resets with each new paycheck affected by that discriminatory action. The law directly addressed *Ledbetter v. Goodyear Tire & Rubber Co.*, a U.S. Supreme Court decision that the statute of limitations for presenting an equal-pay lawsuit begins on the date that the employer makes the initial discriminatory wage decision, not at the date of the most recent paycheck. **Adapted from Wikipedia**
