Although the Statute of Limitations prohibited Heidi from seeking legal action, others could and did, and justice was served.

Now Heidi Wolfe's intention is to help other young women avoid situations like what she experienced. She wants others to notice when something seems awry and bravely speak out.

for next District 5 meeting: **Saturday, February 25, 2017 in Neenah.**

We covered some important items: convention, bylaws, member recognition pins, state-level open positions, NCCWSL scholarships, and branch websites, among them.

I'm so pleased with the progress we made together in planning our upcoming convention . Additional progress since – Our capable former District 5 coordinator Connie Polley has agreed to co-chair the convention. We are still looking for another convention co-chair and a branch to provide decorations/ambiance. Looking through the acknowledgment page of last year's convention booklet I anticipate as convention nears we'll need branches to come forward to handle name tags and convention packets, and serve as special assistants, greeters, workshop monitors, and in miscellaneous roles. Additionally, an area branch may want to come forward to work with local media on publicity. Together our voices will ring, be heard, and be effective for equity!

Highlights illustrate how our district's nine branches are furthering the cause of equity:

- **Appleton:** presented Dr. Julie Mead on public schools and privatization
- **Fond du Lac:** partnered with other groups to sponsor event on human trafficking
- **Green Bay:** women in politics - going beyond the vote; recognizes outstanding area women with Dreamers & Doers award (including two past published volumes)
- **Oshkosh:** annual potluck with AAUW scholarship winners and book sale; water treatment
- **Rhineland/Northwoods:** women in public office; presented on AAUW's "Barriers & Biases" booklet
- **Sheboygan:** raised \$2000 for scholarship (members urged to donate \$1 for every year of their education from K-college) and presented it to non-traditional student at Fall brunch
- **Wausau:** to host US Congressional candidate forum; member to present on public money funding private school vouchers
- **West Bend:** presenting speaker from a local suicide prevention project; lost their book sale
- **Wisconsin Bend:** small membership but has a nearly 100% turnout for programs

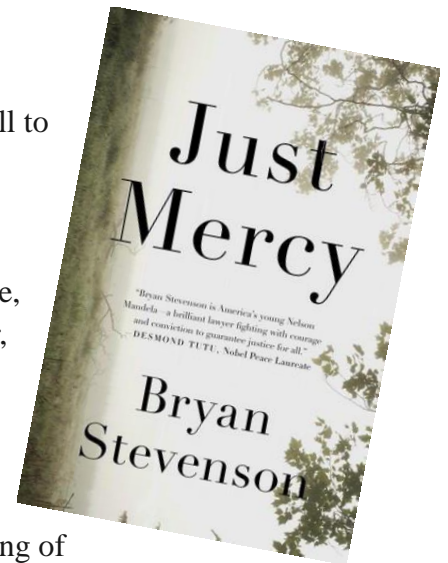

### **Just Mercy** by Bryan Stevenson

#### **December 13 Discussion Leader—Kathy Plein**

A powerful true story about the potential for mercy to redeem us, and a clarion call to fix our broken system of justice—from one of the most brilliant and influential lawyers of our time.

Bryan Stevenson was a young lawyer when he founded the Equal Justice Initiative, a legal practice dedicated to defending those most desperate and in need: the poor, the wrongly condemned, and women and children trapped in the farthest reaches of our criminal justice system. One of his first cases was that of Walter McMillian, a young man who was sentenced to die for a notorious murder he insisted he didn't commit. The case drew Bryan into a tangle of conspiracy, political machination, and legal brinksmanship—and transformed his understanding of mercy and justice forever.

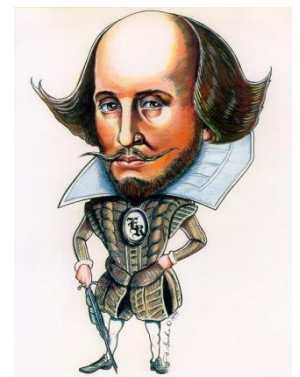


*Just Mercy* is at once an unforgettable account of an idealistic, gifted young lawyer's coming of age, a moving window into the lives of those he has defended, and an inspiring argument for compassion in the pursuit of true justice.

### **Shakespeare's Will** by Vern Thiessen

#### **January 10 Discussion Leader—Marlene Lau**

The drama focuses on the will handed to William Shakespeare's widow Anne as she leaves his funeral. Anne resists reading the will, remembering instead the passion and the vows she shared with her husband, Catholic in public but 'their own kind of marriage' in private. These unusual vows accommodated their desires as individuals, but left Anne alone in Stratford to raise their three children. She relives the decision points where Bill's London life became a separate existence. When plague sweeps the country, she must find a way to protect the children without news or support from William and relates her decision to take them to the seashore, far from disease and death. Her flight repeats her own childhood journey, when her father brought her and her siblings to the sea and away from the plague which killed her mother.



An hour later, Anne must read the will. She understands his bequests until she reads his provision for the house. The play shows us William's success in London through a domestic lens, where Anne's children, garden, bees and marketing are our focus. Anne's own childhood journey to the sea supplies a pattern of water-based imagery which resolves in the final sequence of the play; it is a mirror and cyclic resolution to Bill's love affair with words
