Join AAUW Wausau Branch President Nancy L. Schulz as she recounts her five-week October 2016, solo backpacking adventure by rail through north and central India.

Nancy's previous travels have taken her to North, Central, and South America, Britain, Continental Europe, and the Middle East.

On this journey Nancy traveled by plane, train, ferry, bus, taxi, motorbike, auto, bicycle, hand-pulled-rickshaws, and foot. She slept (fitfully) in crowded overnight trains, hotels, dorms, and a mud hut. She ate food from restaurant, street vendor, market, and friendly families sharing meager provisions. One home where Nancy was welcomed prominently displayed a poster reading, "AUM SWEET AUM" showing pride in their "HOME."

Eighty percent of India is Hindu, and a core belief is reincarnation. One of Nancy's secret goals for this trip was to see if she recognized the land from an earlier incarnation. As with each of her journeys Nancy especially looks forward to sharing insights she gained into the lives of residents whom she met and furthering cultural understanding.

No RSVP is required but a no-pressure opportunity will be available to hear about and join AAUW to further our work for equity for women and girls.



### ***Shakespeare's Will* by Vern Thiessen**

#### **January 10 Discussion Leader—Marlene Lau**

The drama focuses on the will handed to William Shakespeare's widow Anne as she leaves his funeral. Anne resists reading the will, remembering instead the passion and the vows she shared with her husband-- Catholic in public but 'their own kind of marriage' in private. These unusual vows accommodated their desires as individuals, but left Anne alone in Stratford to raise their three children. She relives the decision points where William's London life became a separate existence. When plague sweeps the country, she must find a way to protect the children without news or support from William and relates her decision to take them to the seashore, far from disease and death. Her flight repeats her own childhood journey, when her father brought her and her siblings to the sea and away from the plague which killed her mother.




An hour later, Anne must read the will. She understands his bequests until she reads his provision for the house. The play shows us William's success in London through a domestic lens, where Anne's children, garden, bees and marketing are our focus. Anne's own childhood journey to the sea supplies a pattern of water-based imagery which resolves in the final sequence of the play; it is a mirror and cyclic resolution to William's love affair with words

### ***Dark Money: The History of the Billionaires Behind the Rise of the Radical Right* by Jane Mayer**

#### **February 14 Discussion Leader—to be determined**

Why is America living in an age of profound economic inequality? Why, despite the desperate need to address climate change, have even modest environmental efforts been defeated again and again? Why have protections for employees been decimated? Why do hedge-fund billionaires pay a far lower tax rate than middle-class workers?



The conventional answer is that a popular uprising against “big government” led to the ascendancy of a broad-based conservative movement. But as Jane Mayer shows in this powerful, meticulously reported history, a network of exceedingly wealthy people with extreme libertarian views bankrolled a systematic, step-by-step plan to fundamentally alter the American political system. The network has brought together some of the richest people on the planet. Their core beliefs—that taxes are a form of tyranny; that government oversight of business is an assault on freedom—are sincerely held. But these beliefs also advance their personal and corporate interests: Many of their companies have run afoul of federal pollution, worker safety, securities, and tax laws.

Jane Mayer spent five years conducting hundreds of interviews—including several sources within the network—and scoured public records, private papers, and court proceedings in reporting this book. In a taut and utterly convincing narrative, she traces the byzantine trail of the billions of dollars spent by the network and provides vivid portraits of the colorful figures behind the new American oligarchy.

*Dark Money* is a book that must be read by anyone who cares about the future of American democracy.



As many of you know, AAUW's Chief Executive Officer Linda Hallman retired in July after eight years of service to the AAUW mission. During her tenure, we saw our research continue to shape national conversations on women's representation in science, technology, and leadership. We saw the Lilly Ledbetter Fair Pay Act signed into law and expanded our local equal pay work in statehouses. Linda was also instrumental in overseeing AAUW's recent move to 1310 L St. NW — a new space, but the same mission! We thank her for her many contributions and wish her success in her future endeavors.

AAUW immediately commenced the process of selecting the next chief executive officer and appointed a search committee comprising members Joanna Amberger, Betsy McDowell, Dot McLane, Glenda Price, and Pamella Thiel and chaired by Peggy Williams and Krys Wulff. Requests for proposals were initially sent to a number of firms, and three were included in final consideration.

The committee is confident that AAUW has engaged a search firm that will recommend the right person at the right time to move AAUW forward, and I'm eager to announce our new leader at the [2017 AAUW National Convention](#) in June.

Here's to a wonderful year of growth and empowerment! I hope I see many of you in Washington, D.C., in June as we make our announcement and take AAUW to even greater heights.
